WAIVER

I acknowledge that I will use the property and facilities arranged for me by MMFC at my own risk. I hereby hold harmless MMFC, its executive and the owners of any such property and facilities from any suit, cause, action or claim resulting from my use of such property or facility.

If I have indicated that I am a student, I hereby request that the MMFC provide me with instruction in the flying of radio controlled model aircraft. I understand that volunteer instructors who are skilled model pilots, will operate my model as safely and responsibly as possible, and will provide instruction without charge.

I agree to hold the MMFC, its officers, directors and instructors blameless in the event of any accidents involving damage or loss of models or property, personal injury, or loss of life resulting from the operation of my model aircraft. Regardless of whether said aircraft was under the control of an instructor, or myself at the time of the accident.

MMFC acknowledges that this waiver does not affect the applicant's right or benefits under any insurance that is provided by MAAC or the applicant.
